#### CALL OUT FOR APPLICATIONS - Youth Social Action Fund & John Laing Fund

We are delighted to re-open the Youth Social Action Fund and the John Laing Charitable Trust Fund until 12 noon on Monday 5th February.

**Youth Social Action Fund** - grants are available of up to £5,000 to increase the number of young people aged 10 to 20 (and up to 25 for disabled young people) getting involved in youth social action and volunteering in Hackney, Newham, Tower Hamlets and the City of London.

**John Laing Charitable Trust Fund** - grants are available of up to £1,000 for organisations with an income of under £300,000 for projects addressing homelessness, disadvantaged young people, education and community regeneration (including the elderly) in Hackney, Newham, Tower Hamlets and the City of London.
